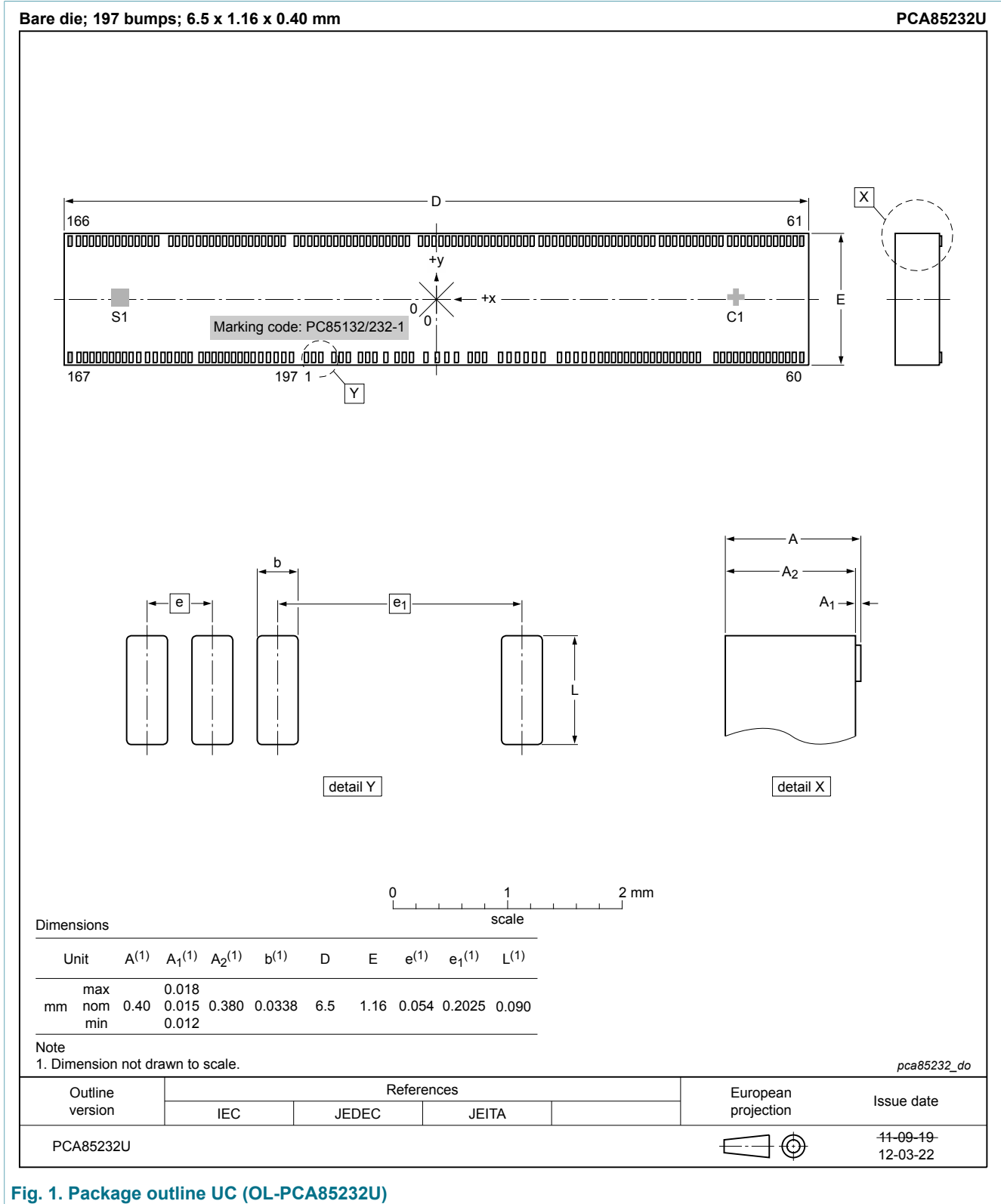


Fig. 1. Package outline UC (OL-PCA85232U)
