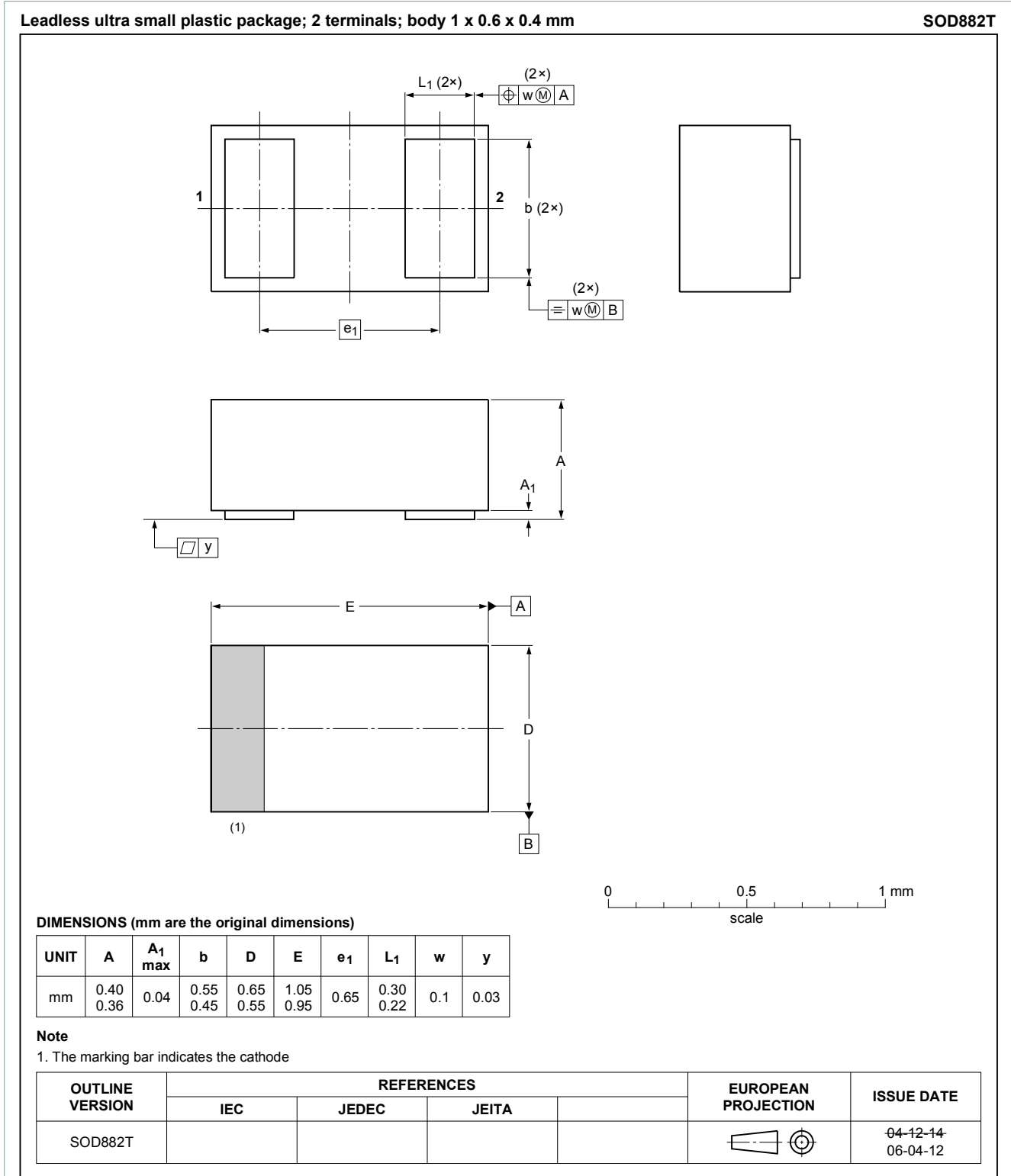


Fig. 1. Package outline SOD2 (SOD882T)
