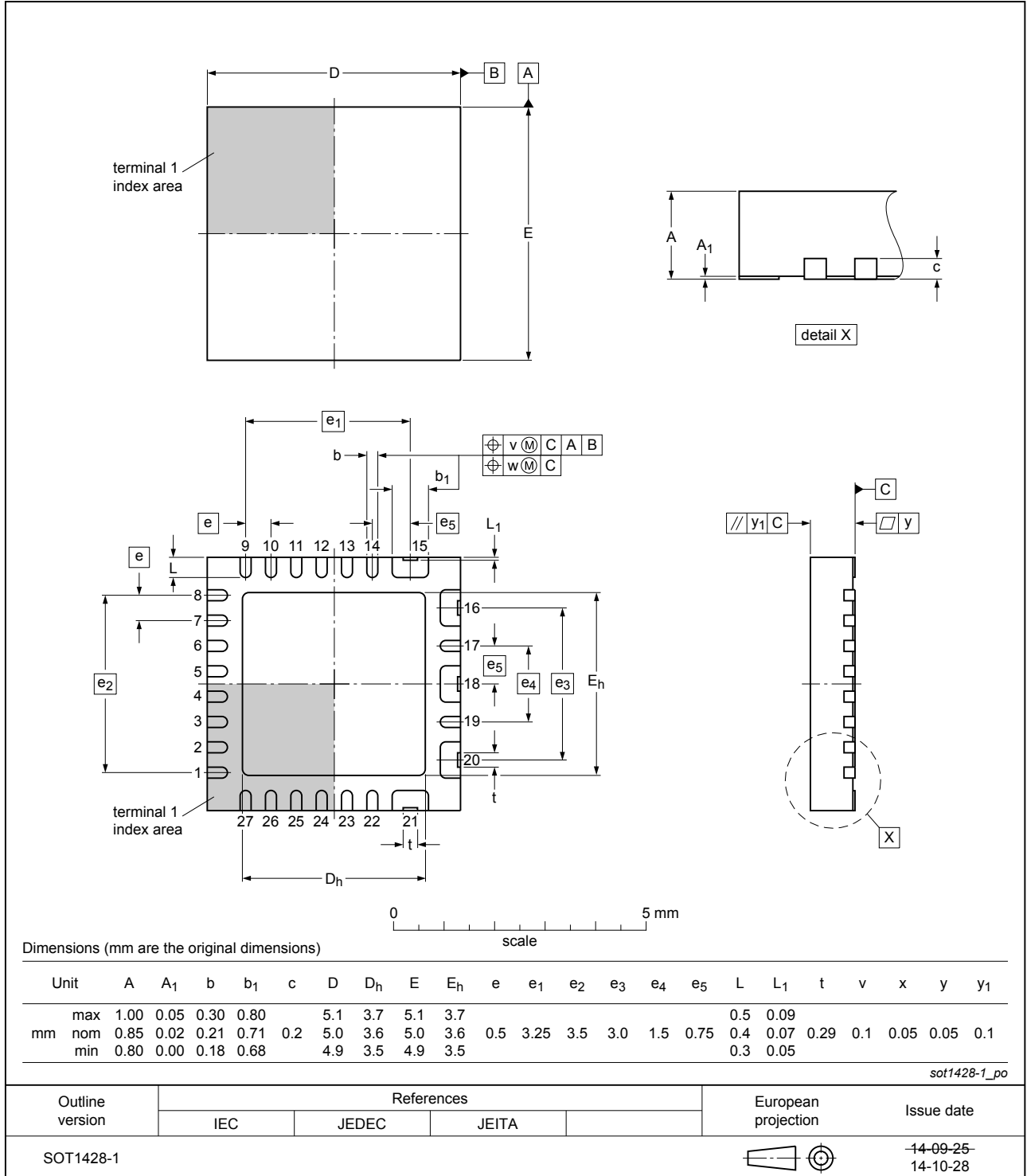


Fig. 1. Package outline HVQFN27 (SOT1428-1)
