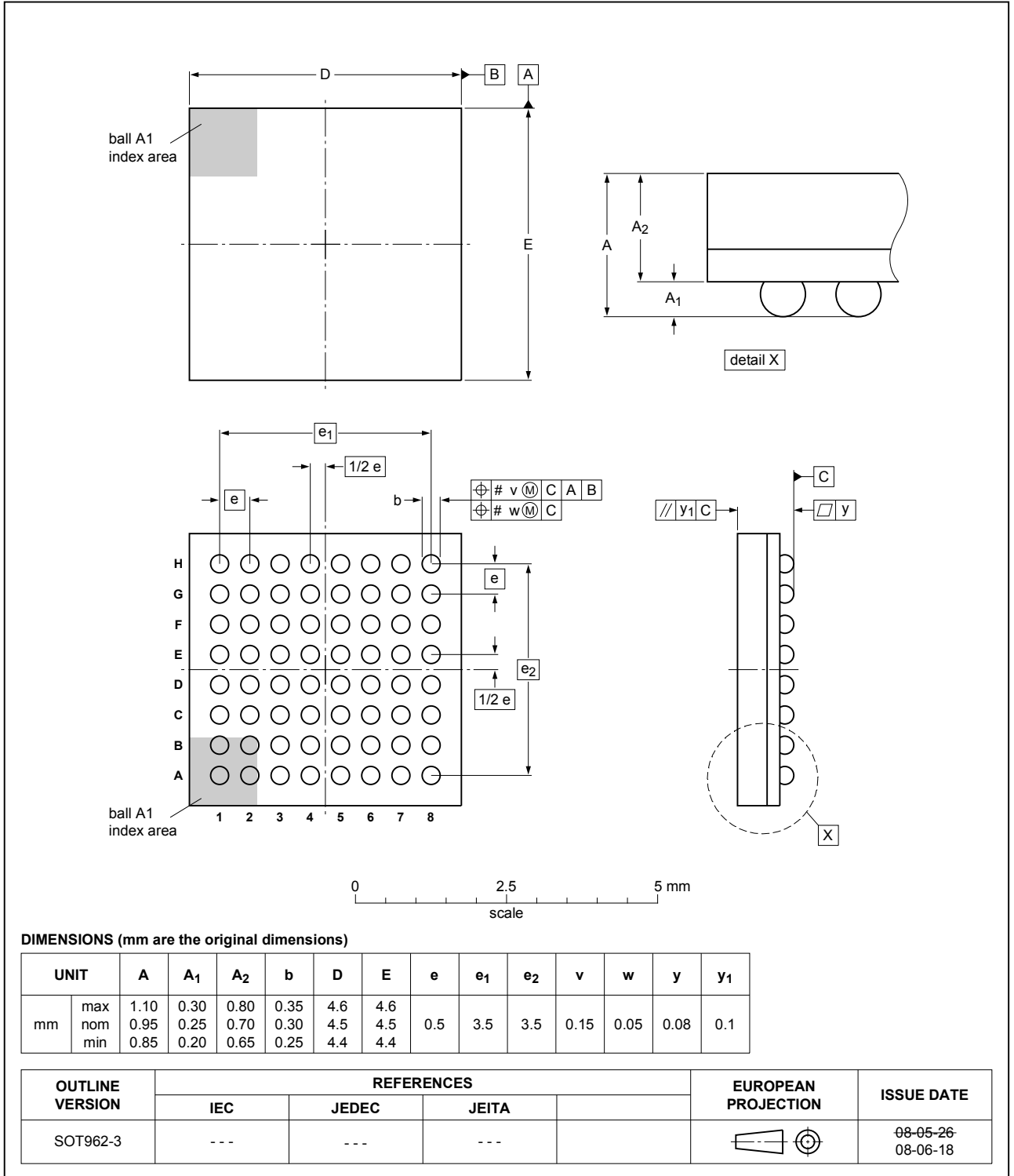


Fig. 1. Package outline TFBGA64 (SOT962-3)

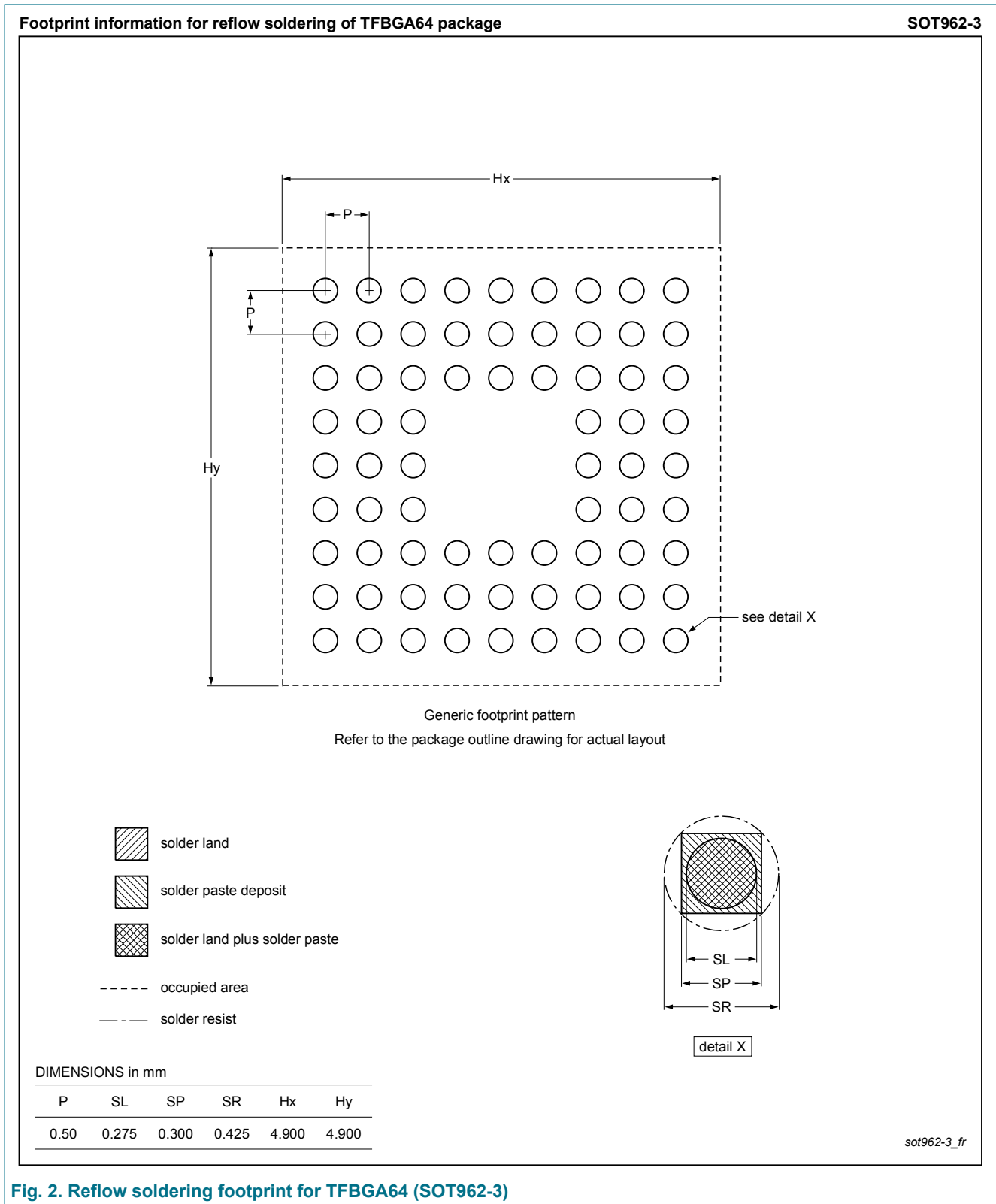


Fig. 2. Reflow soldering footprint for TFBGA64 (SOT962-3)
