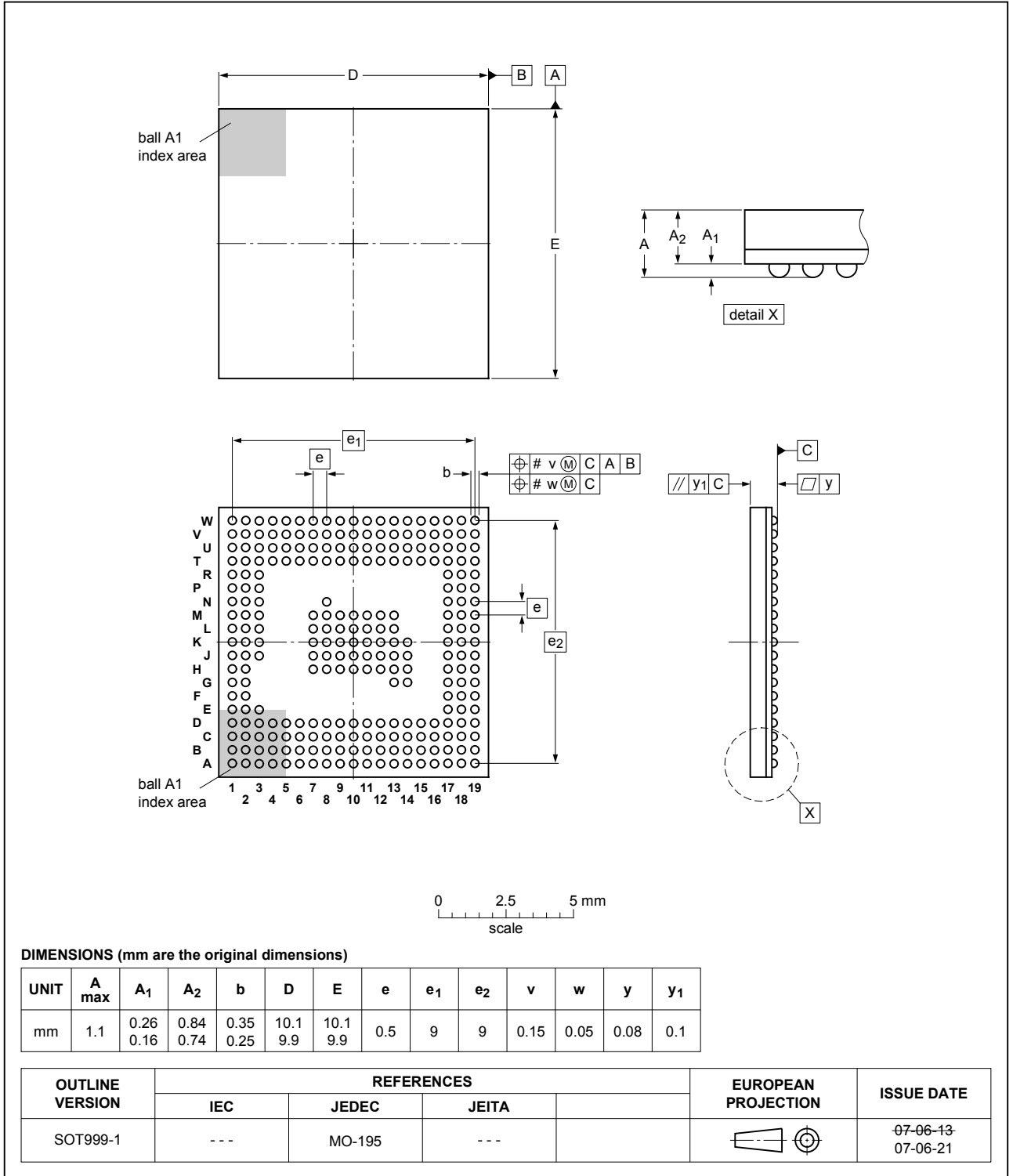


Fig. 1. Package outline TFBGA256 (SOT999-1)

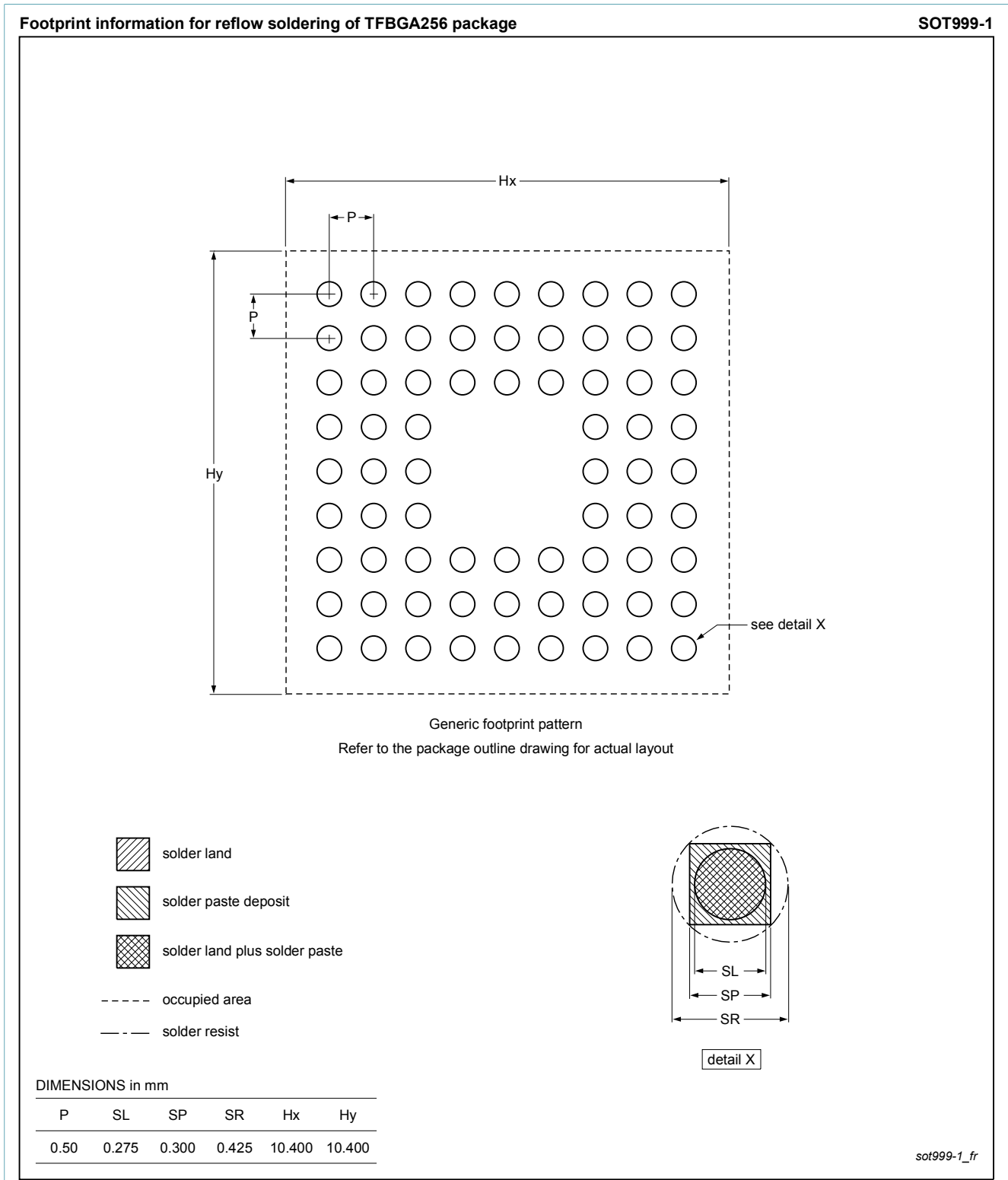


Fig. 2. Reflow soldering footprint for TFBGA256 (SOT999-1)
