The TED-Kit 2 system version 3.6.0 consists of the following components:

API Library	4.1.0	The application programmer's interface to access the TED-Kit 2 hardware functionality.
FTDI Driver	2.12.00	The device driver for the TED-Kit 2 hardware.
Firmware	2.0	The firmware running on the TED-Kit 2 hardware.

3. Implemented Modifications

3.1 GUI

The following modifications were implemented in the GUI:

- SC48211:Unexpected communication failures reported by customers
- SC48804:WFS5c: introduce PAIR command in tedkit2 gui.
- SC49290:Show device driver version in hex
- SC49268:WFS5c: PING command does not show correct device mode PROTECTED

The following modifications were implemented in the API:

- Added support for WFS-5c PAIR command

- SC48849:Update the TED-Kit 2 device driver
