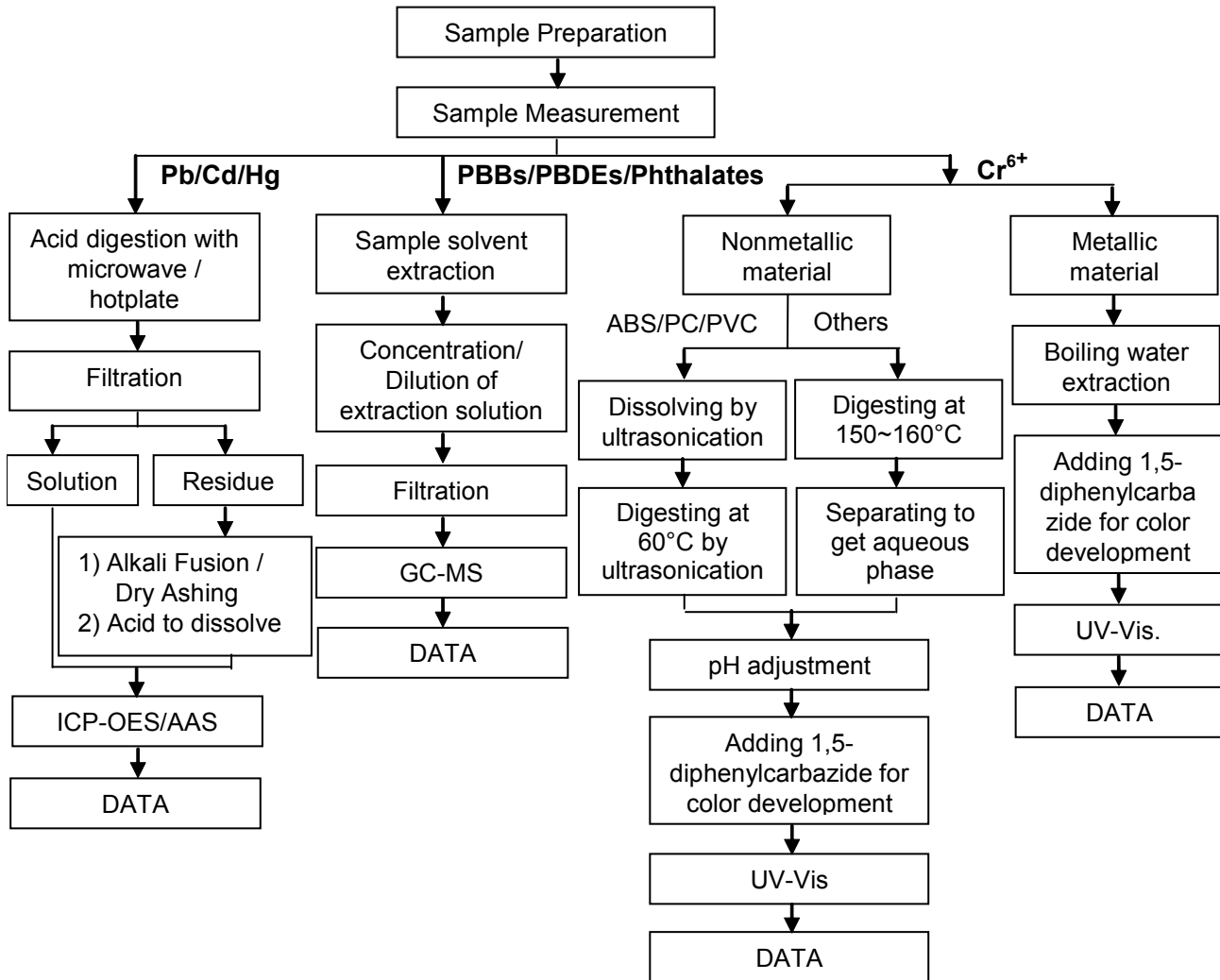

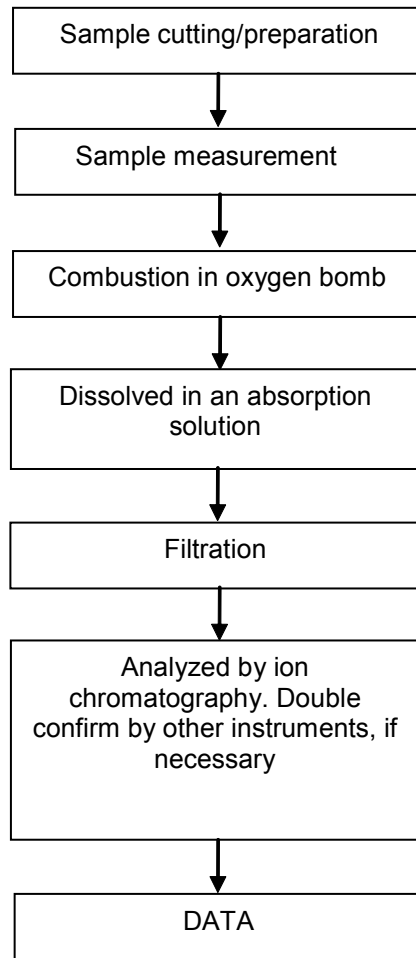

**Halogen Testing Flow Chart**

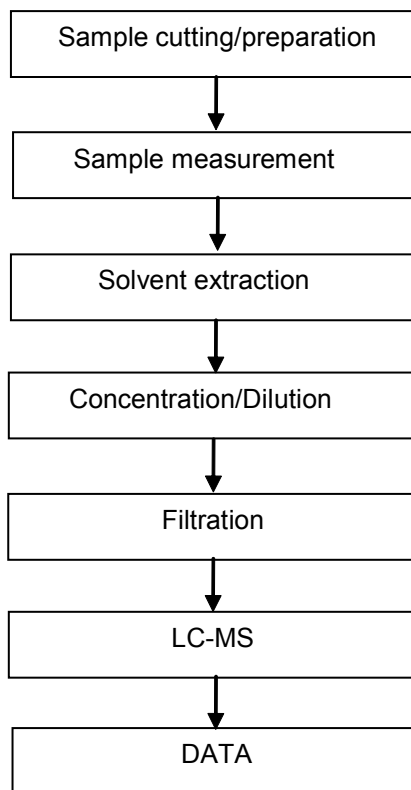

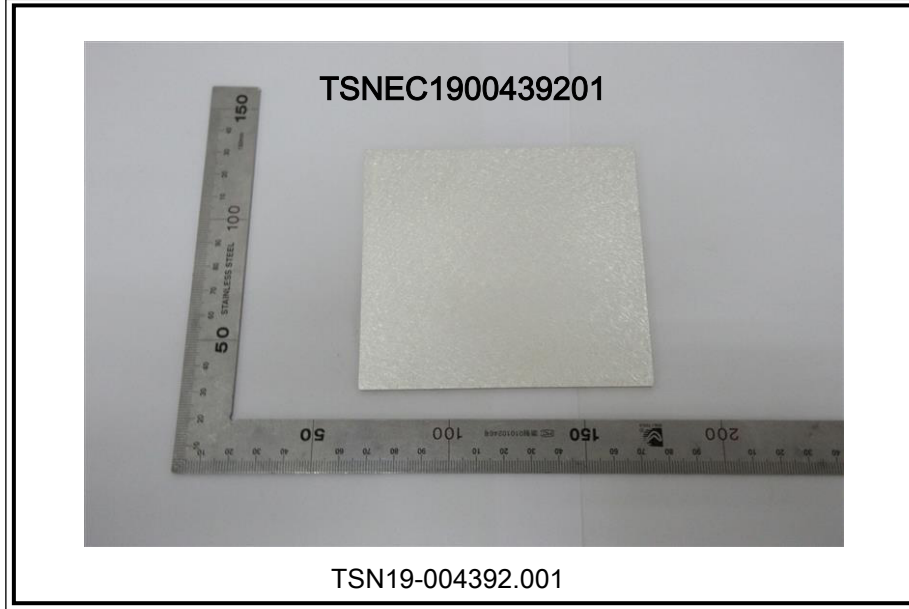
PFOS/PFOA Testing Flow Chart
