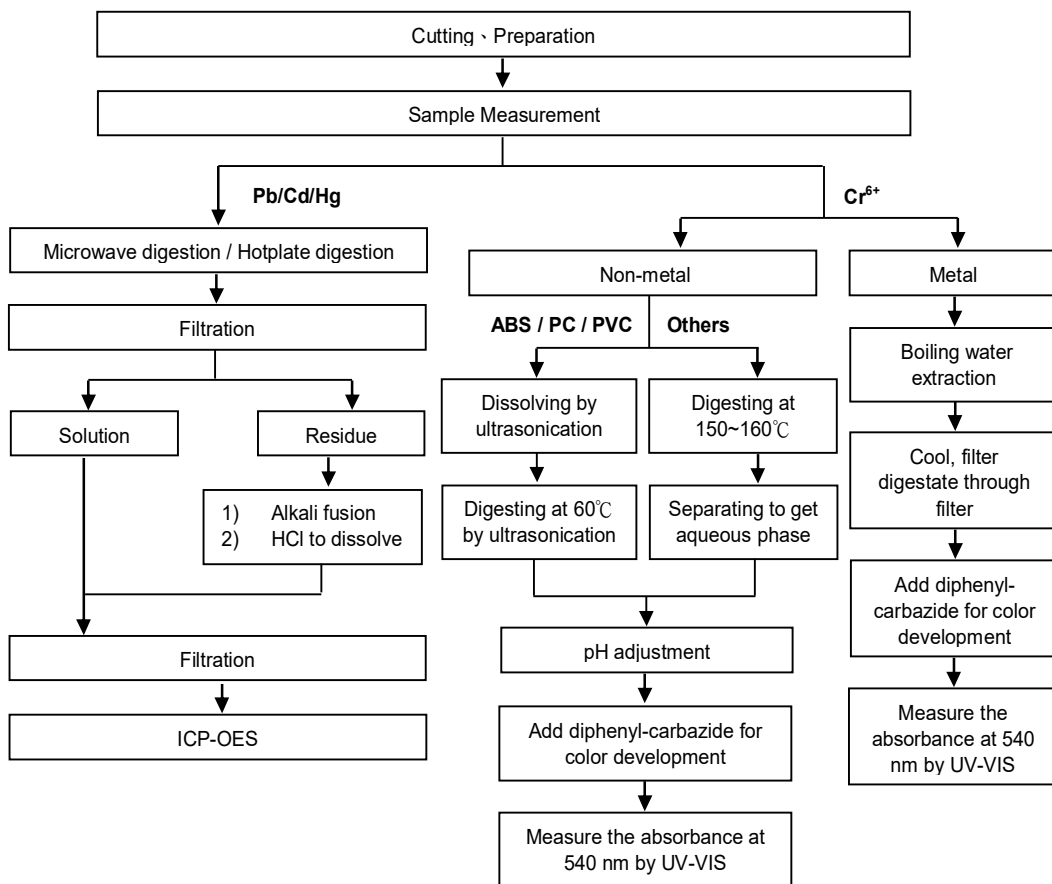

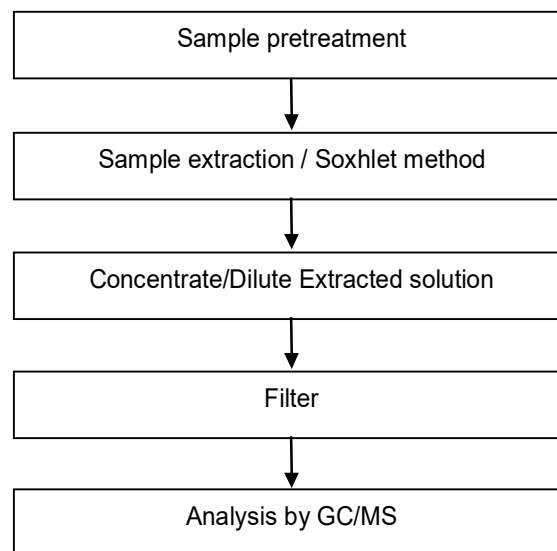

PBB/PBDE analytical FLOW CHART



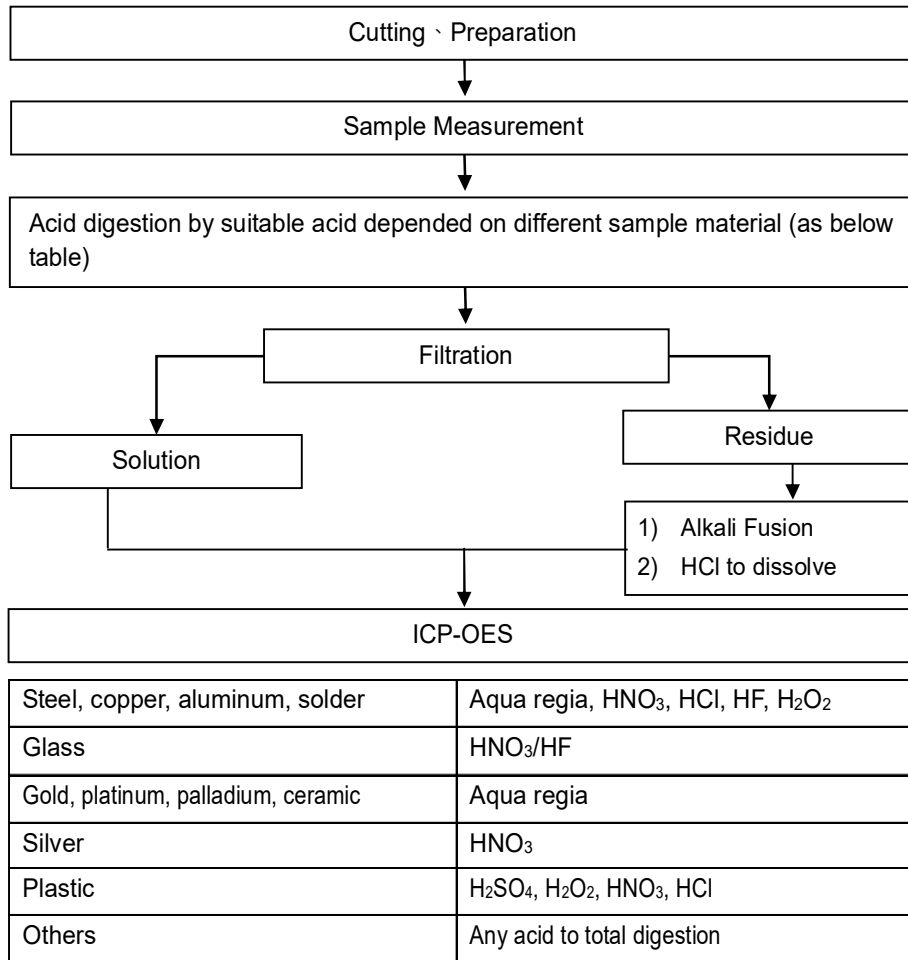

Flow Chart of digestion for the elements analysis performed by ICP-OES

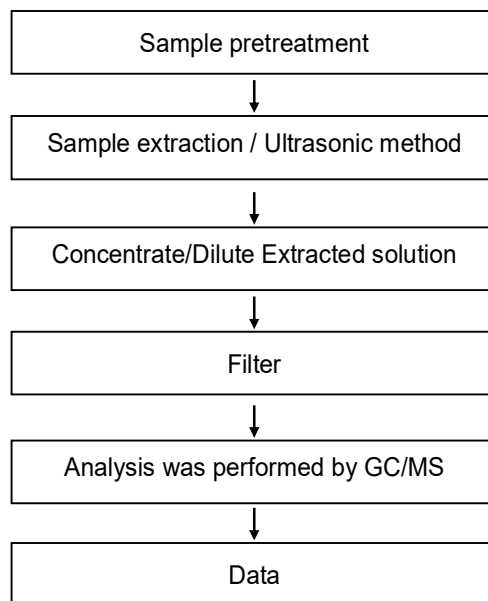

HBCDD analytical flow chart

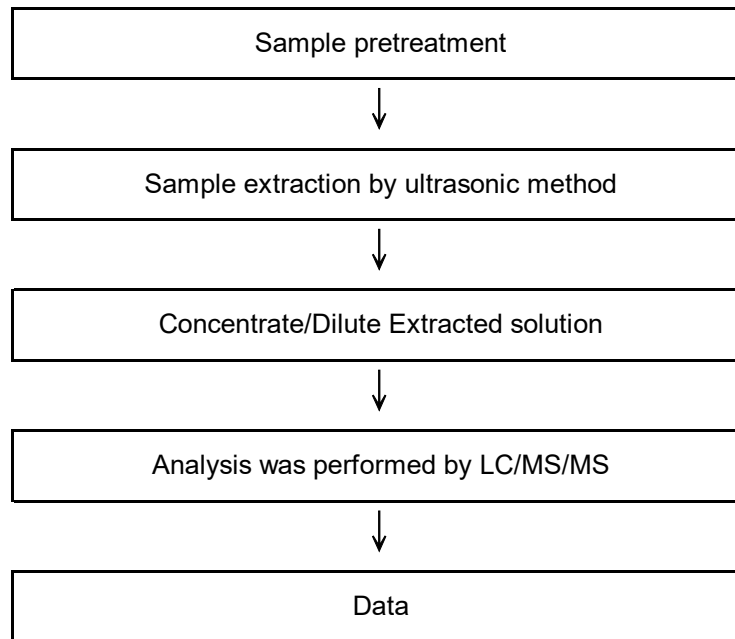

Analytical flow chart of PFOA/PFOS

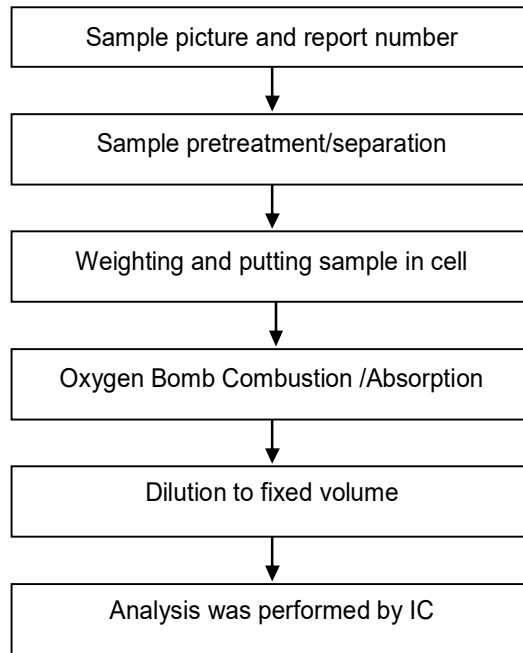

Analytical flow chart of Halogen



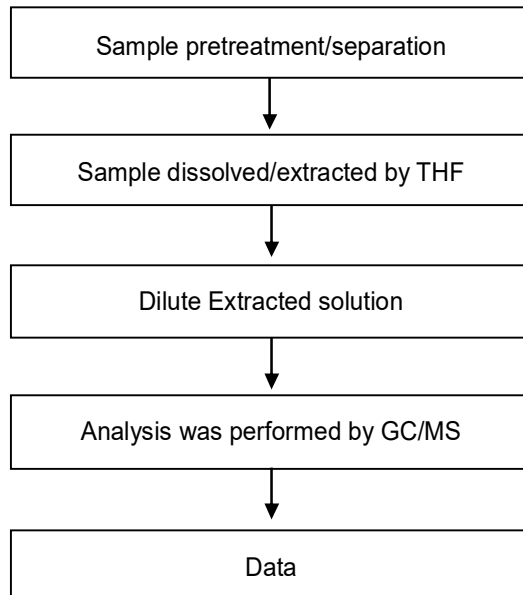

Analytical flow chart of phthalate content

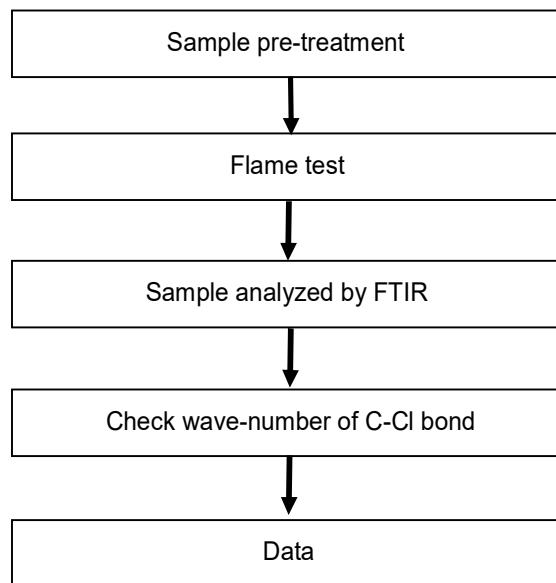
