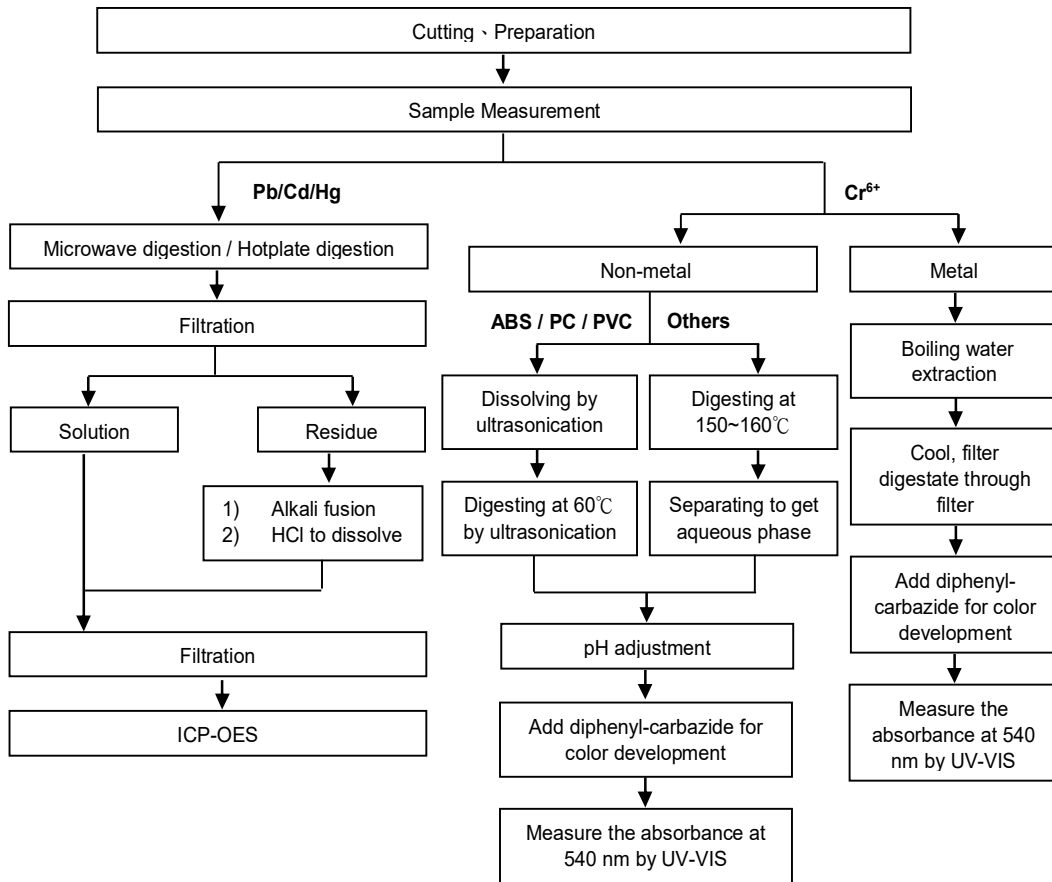

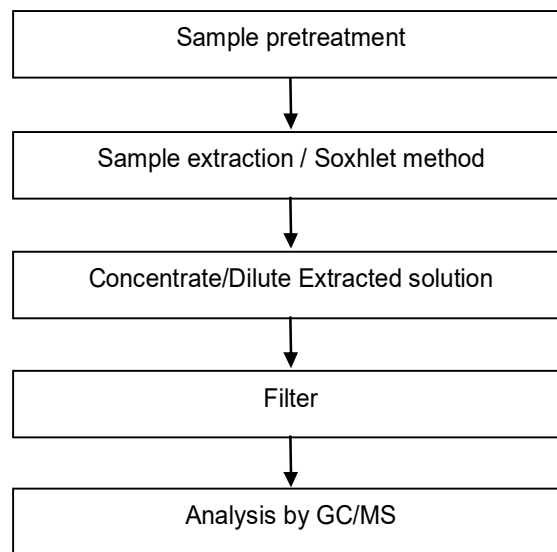

### PBB/PBDE analytical FLOW CHART

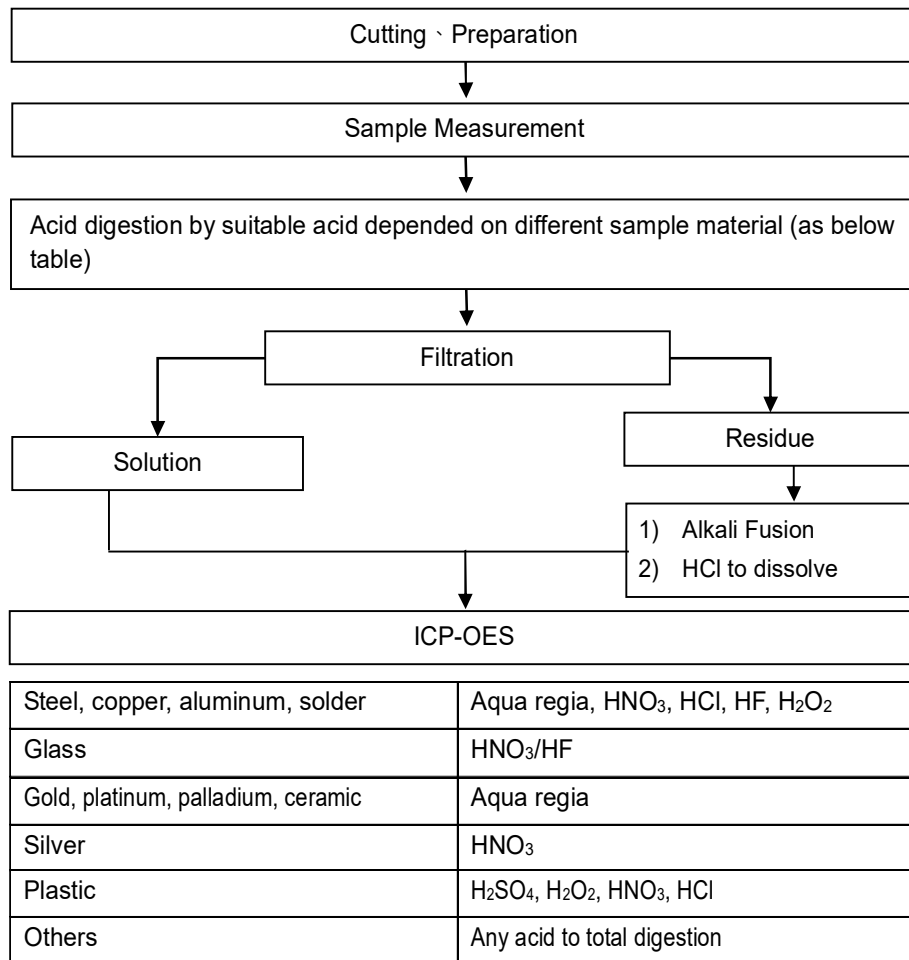

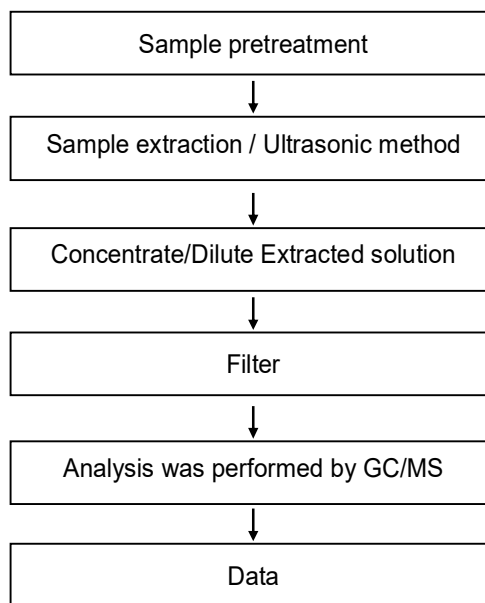

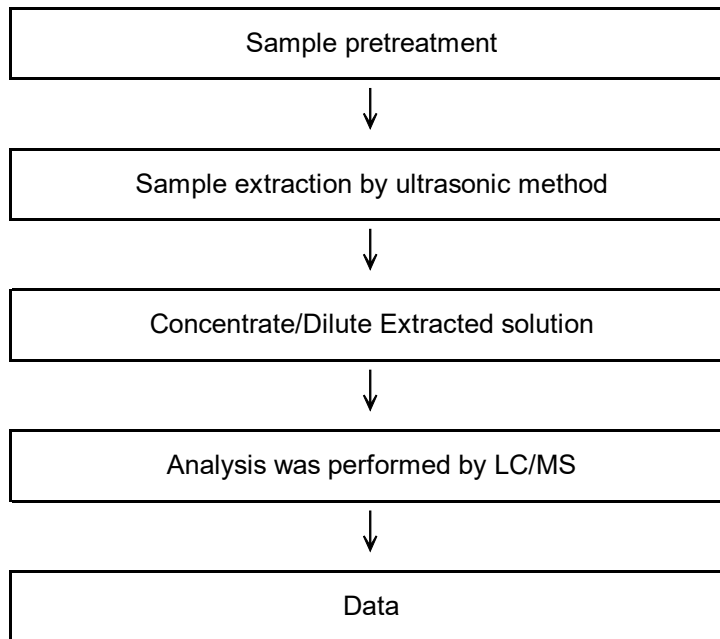

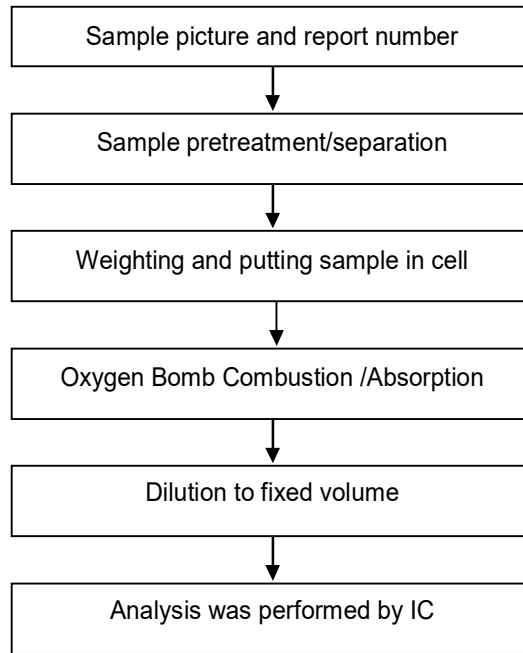
## Analytical flow chart of PFOA/PFOS

### Analytical flow chart of Halogen

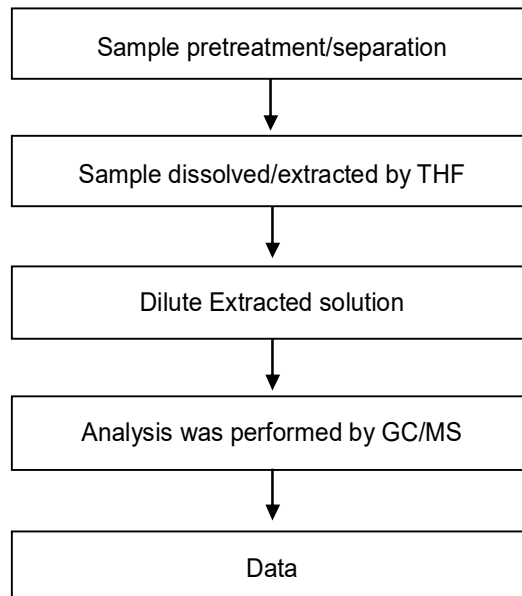

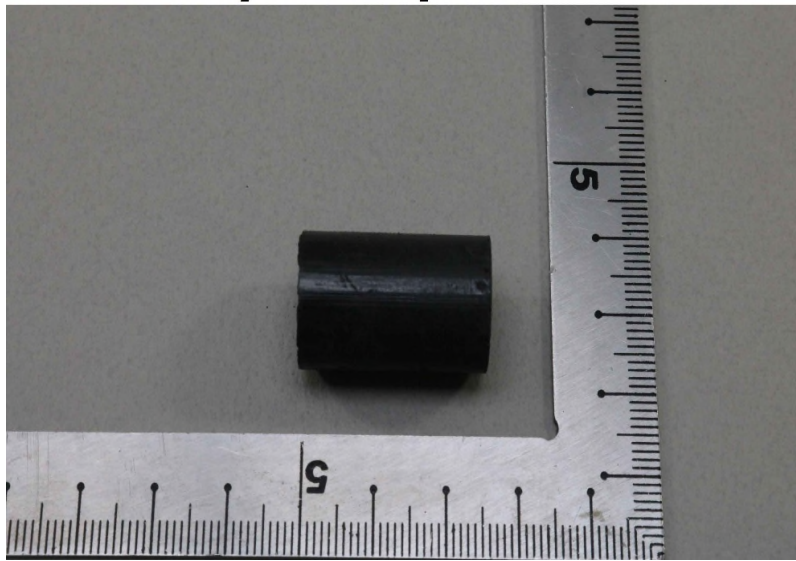
