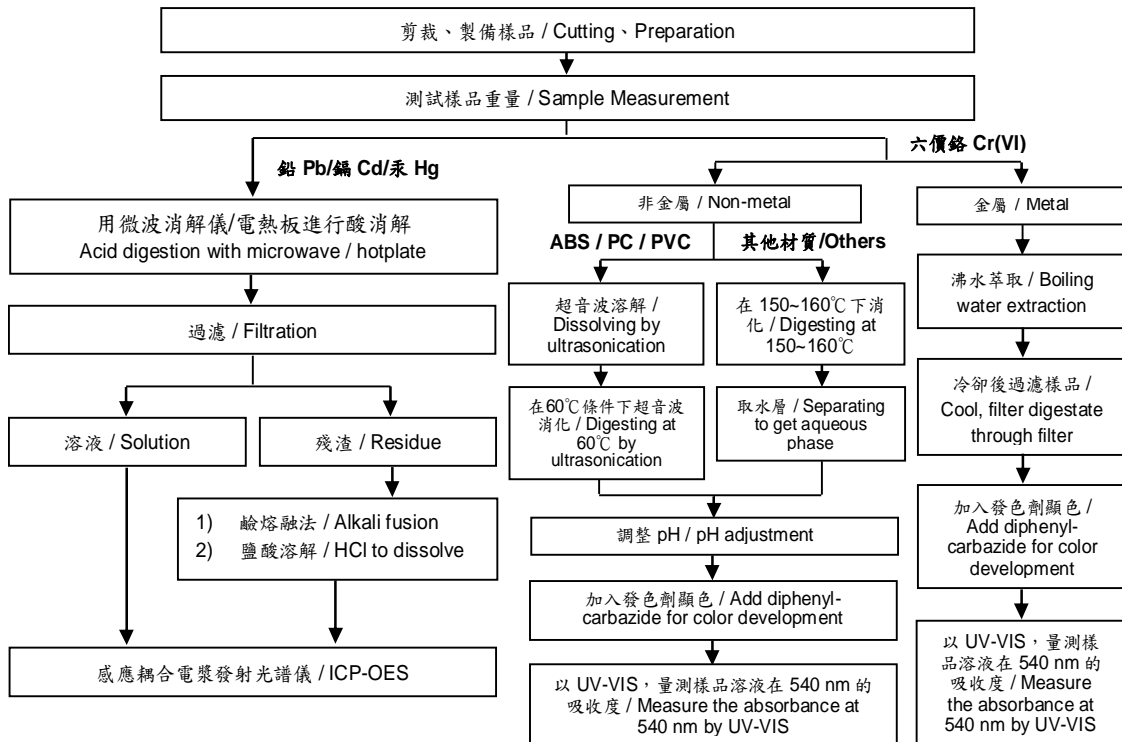

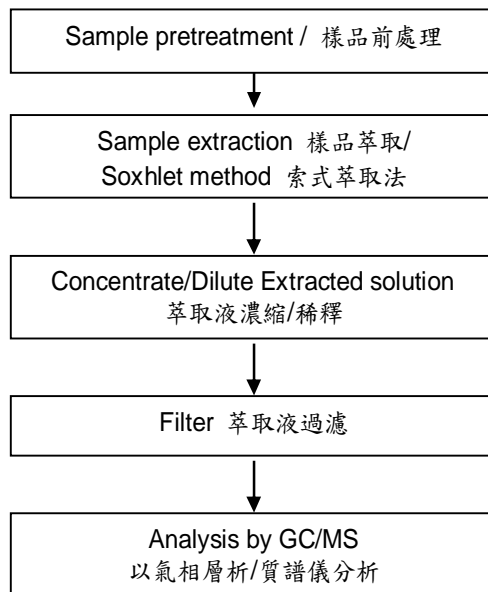

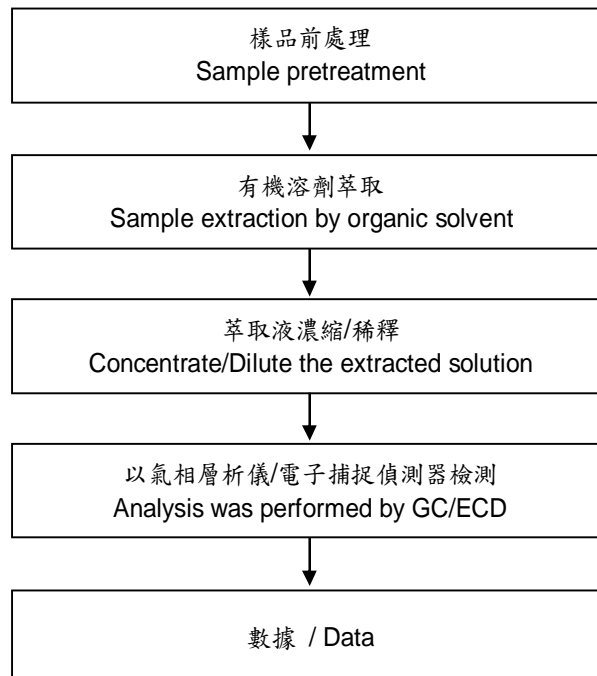

氯化石蠟分析流程圖 / Analytical flow chart - Chlorinated Paraffins

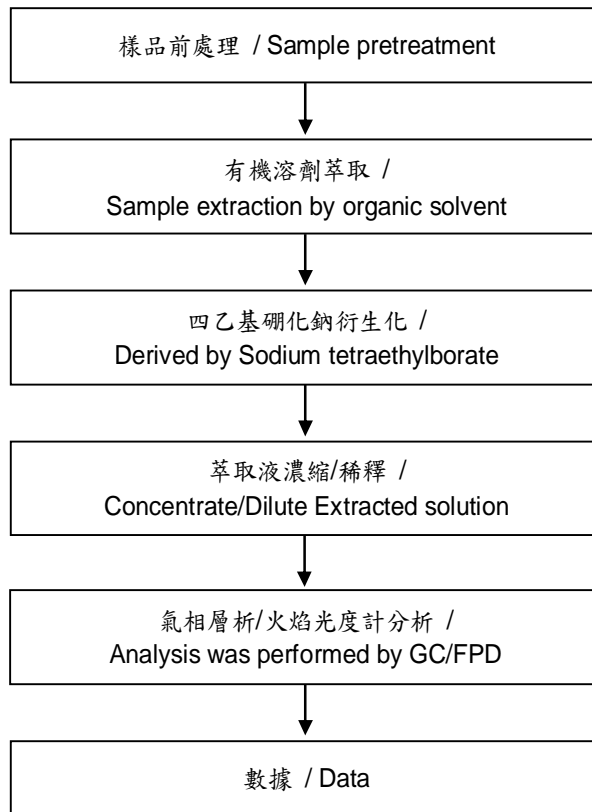

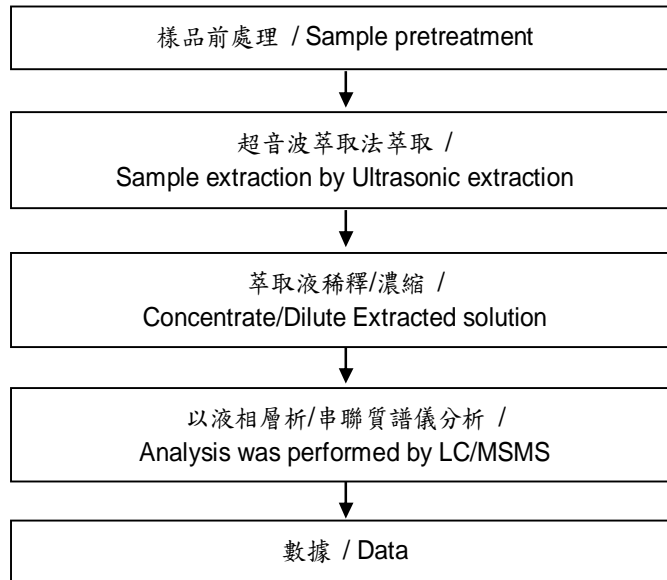

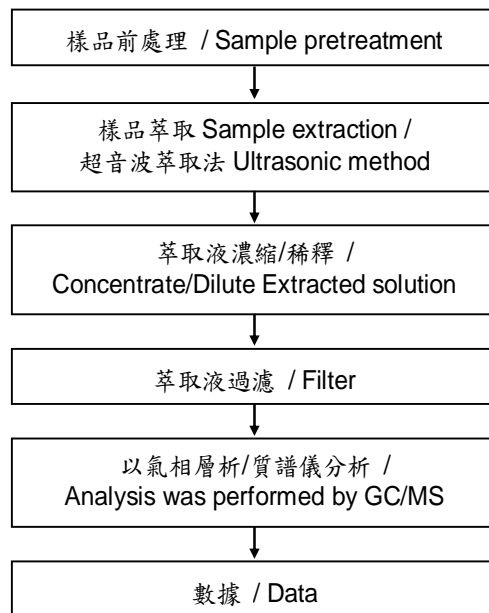

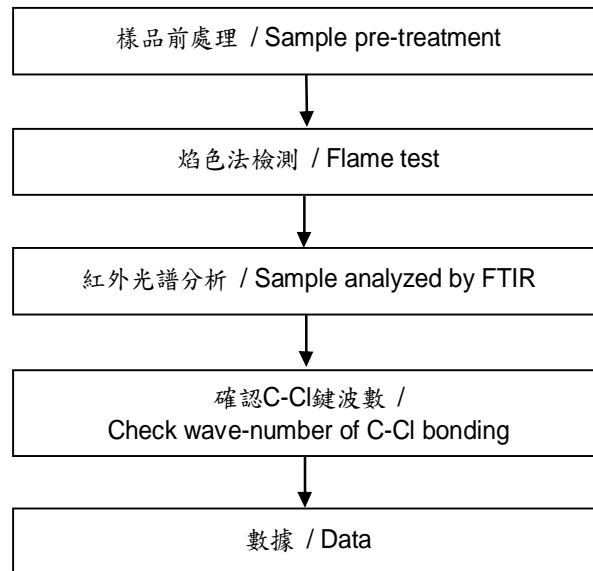

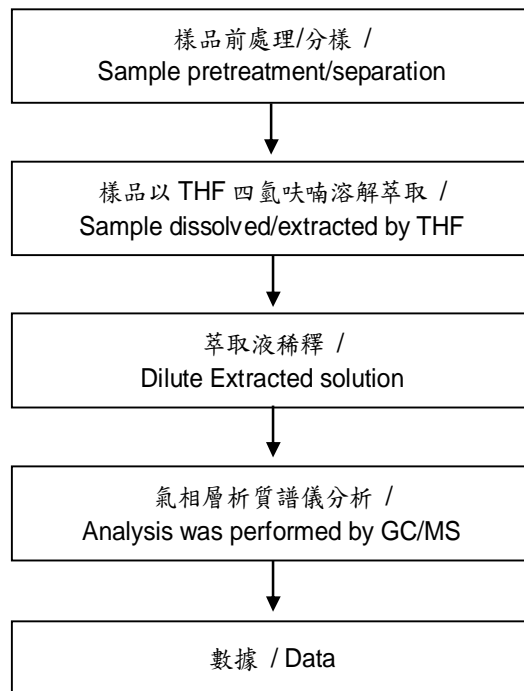

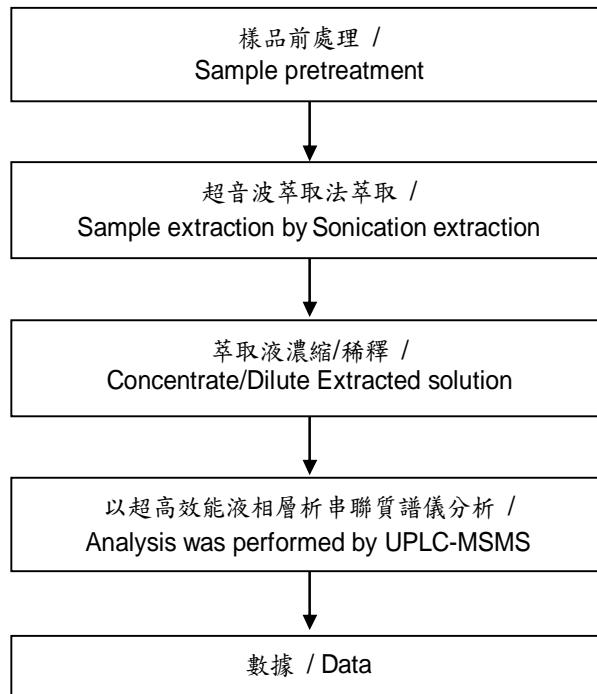
可塑劑分析流程圖 / Analytical flow chart of phthalate content

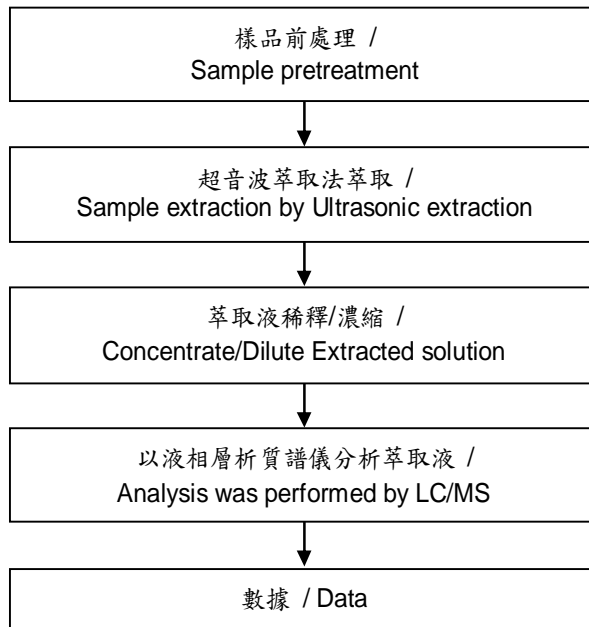
雙酚A分析流程圖 / Bisphenol A analytical flow chart

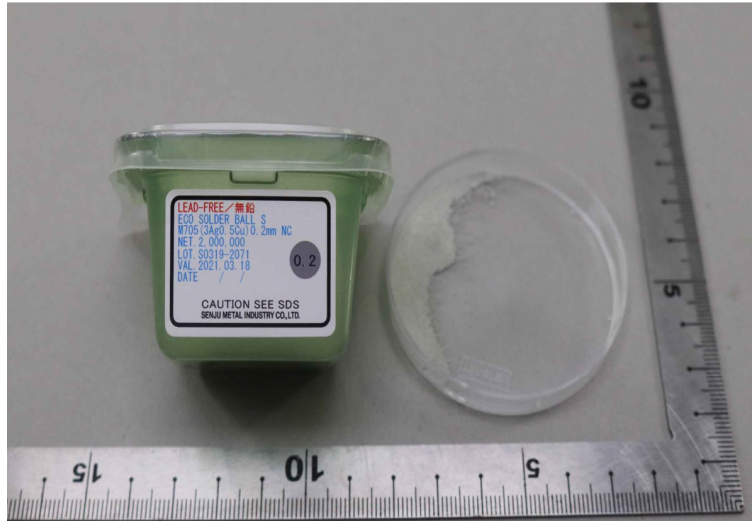
