

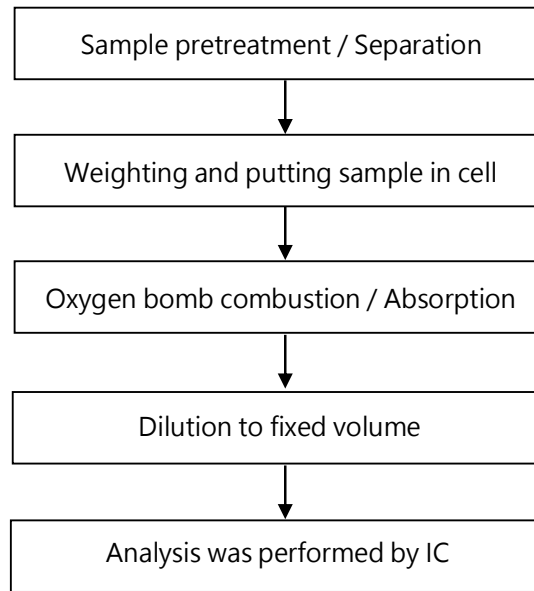

### Analytical flow chart - Halogen

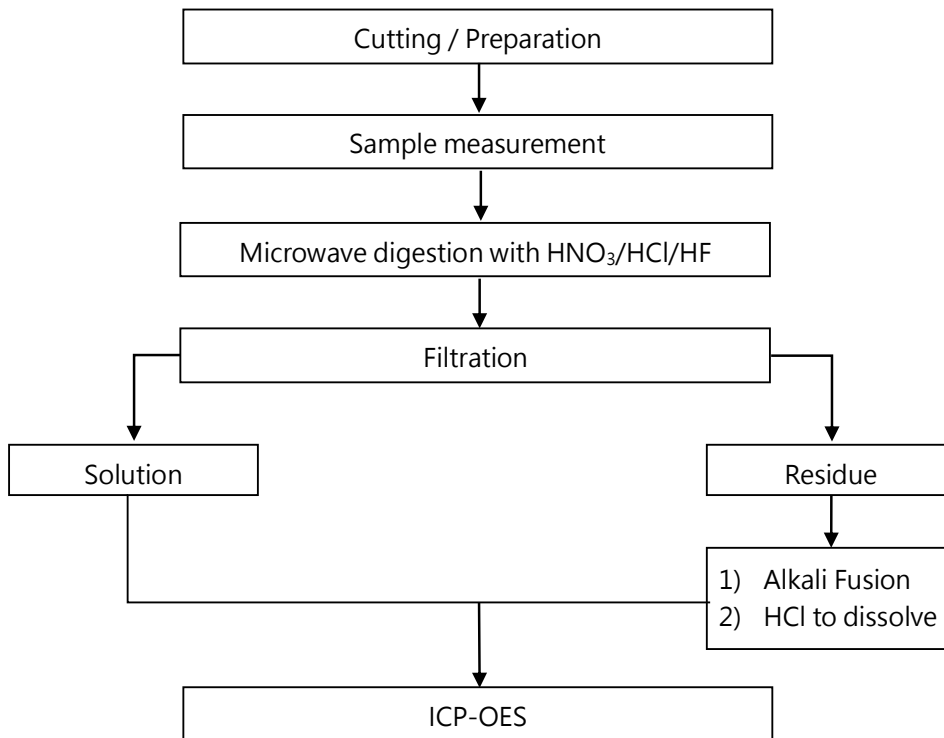

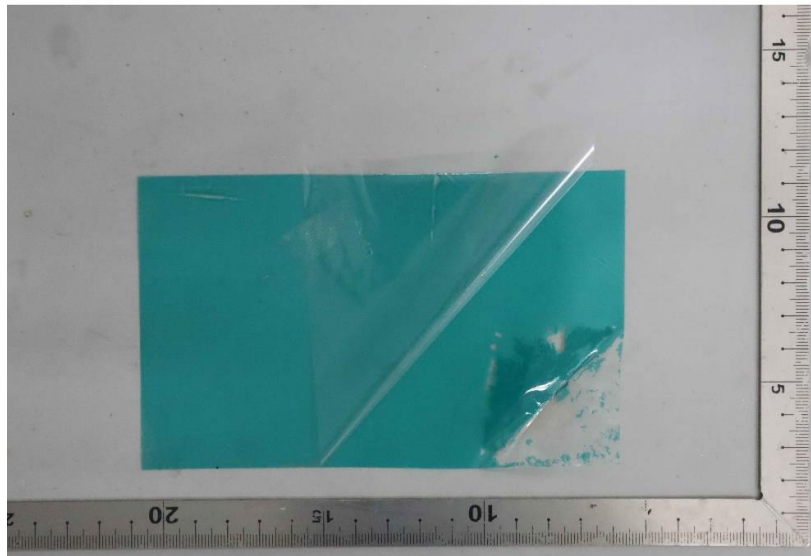
