

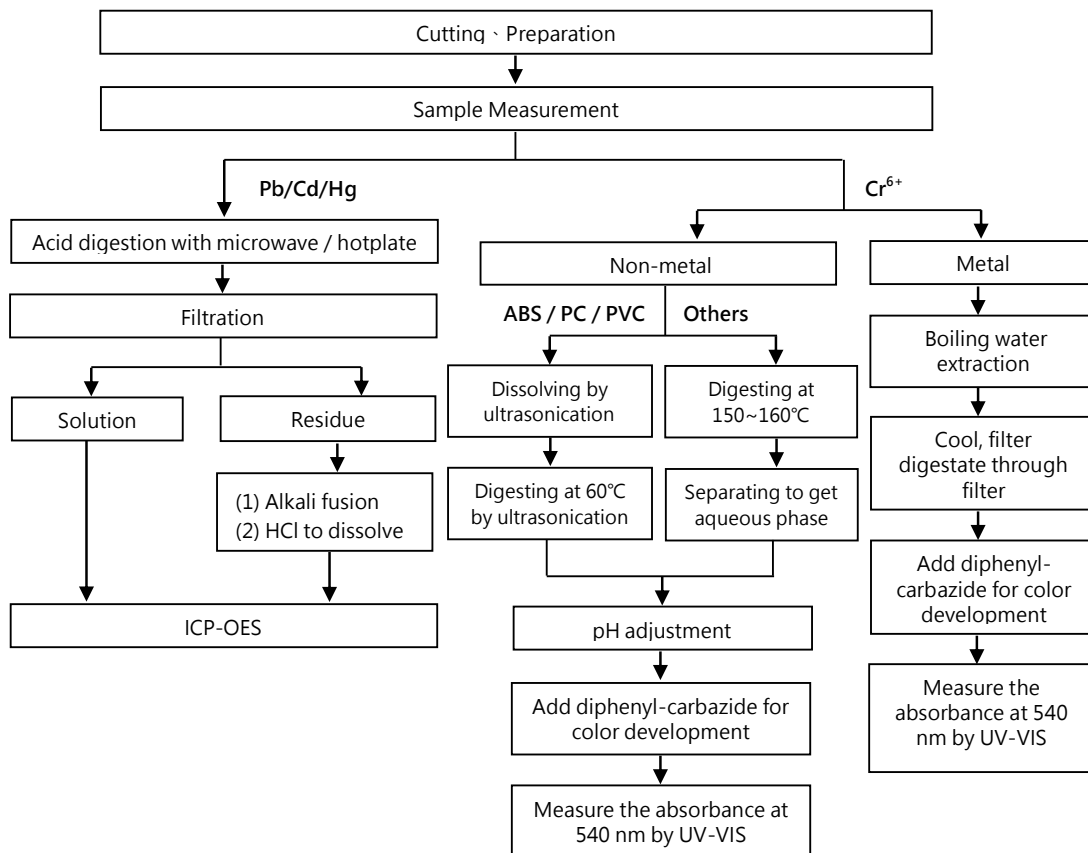

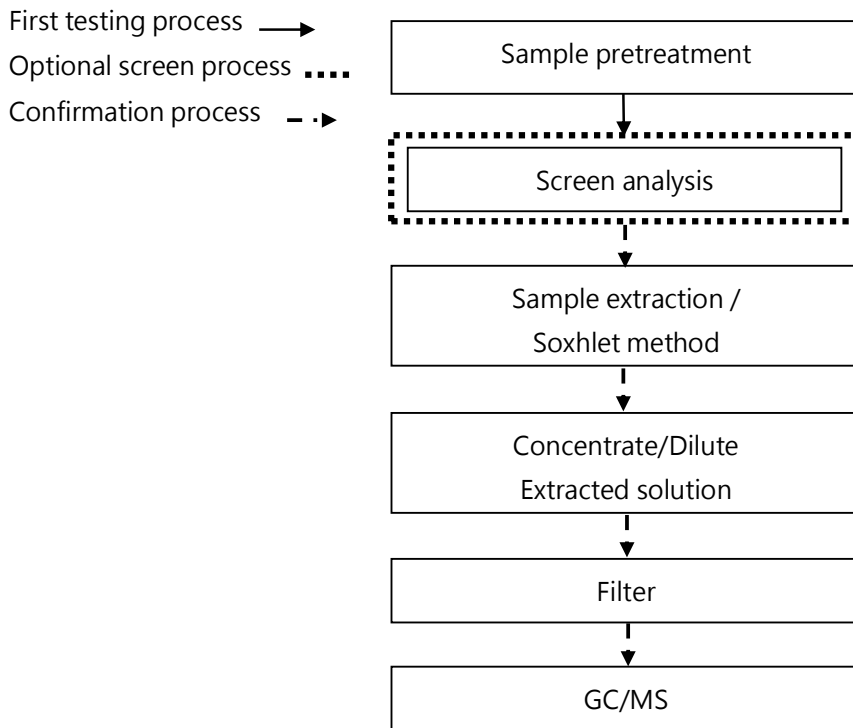
Analytical flow chart of Heavy Metal

Analytical flow chart – PBBs / PBDEs



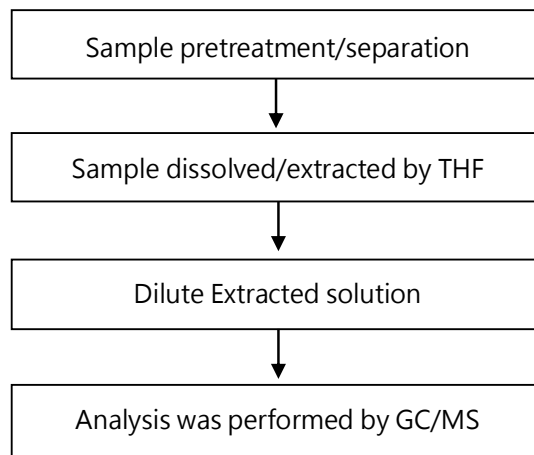
