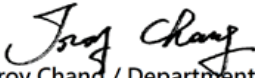

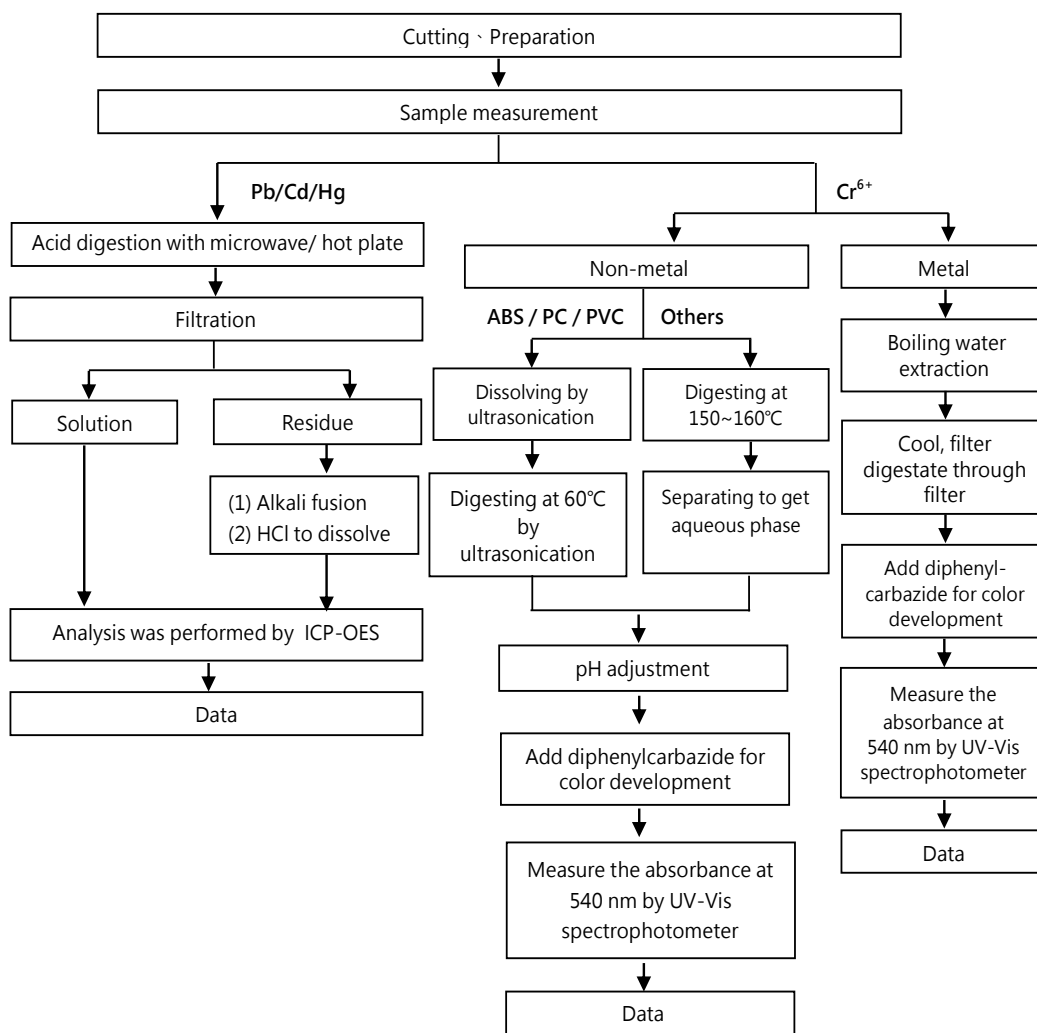

(Cr^{6+} test method excluded)

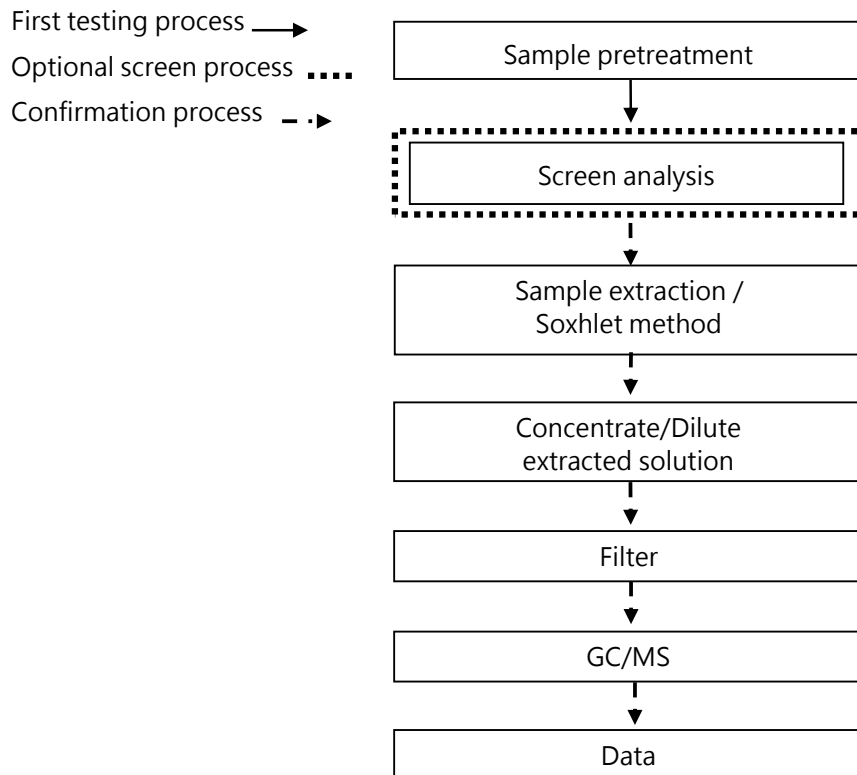

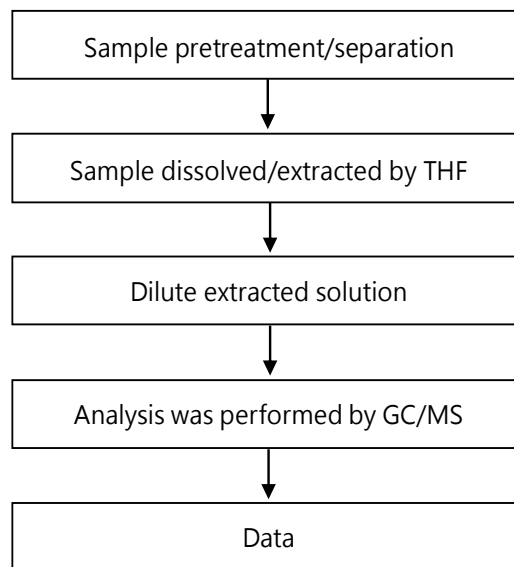
