甲醛分析流程圖 / Analytical flow chart - Formaldehyde

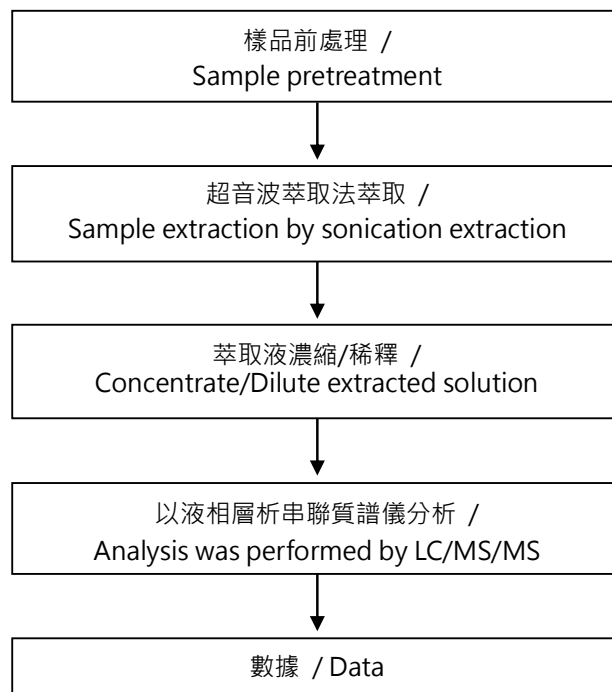

雙酚A分析流程圖 / Analytical flow chart - Bisphenol A



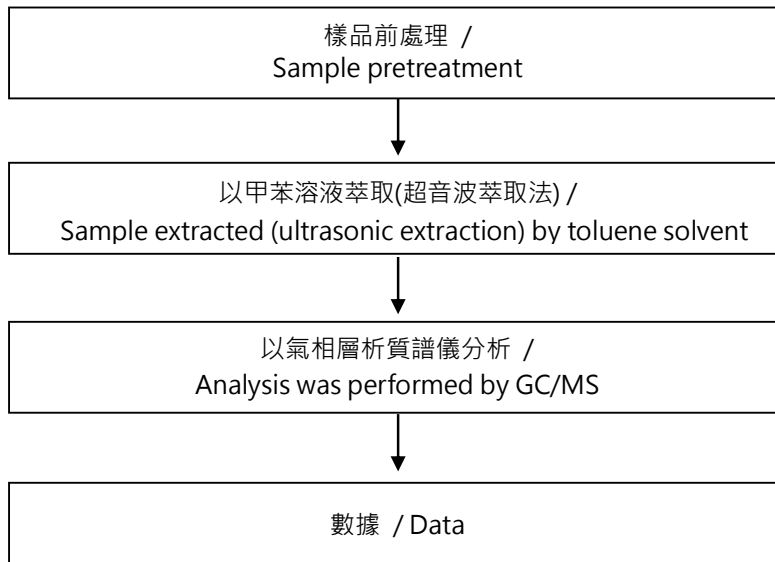

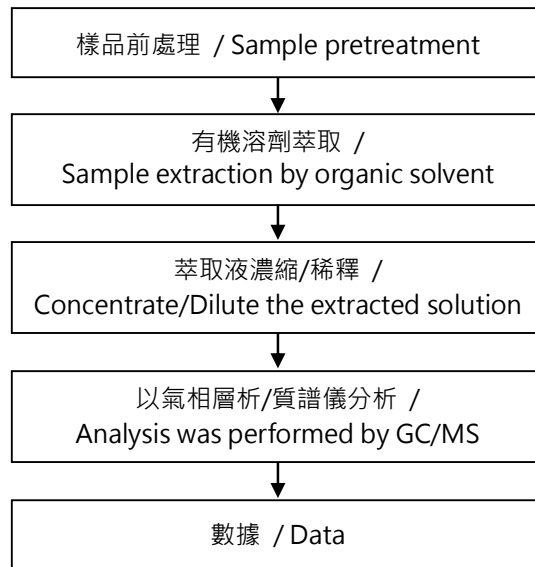

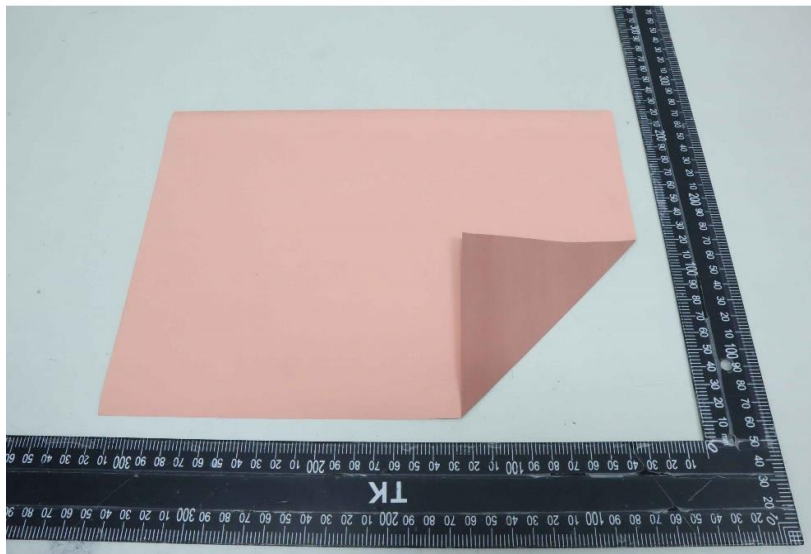
