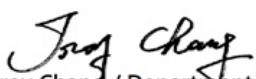

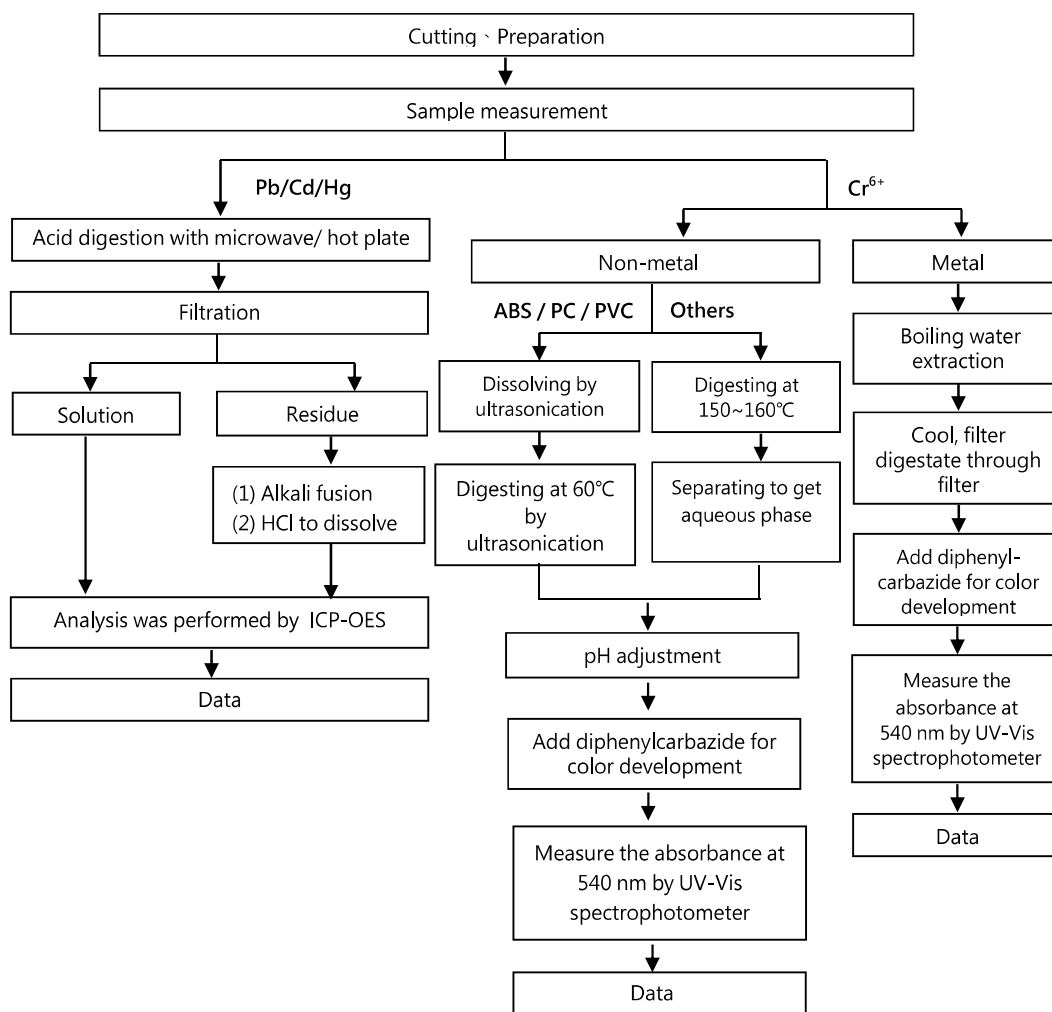

Analytical flow chart of heavy metal

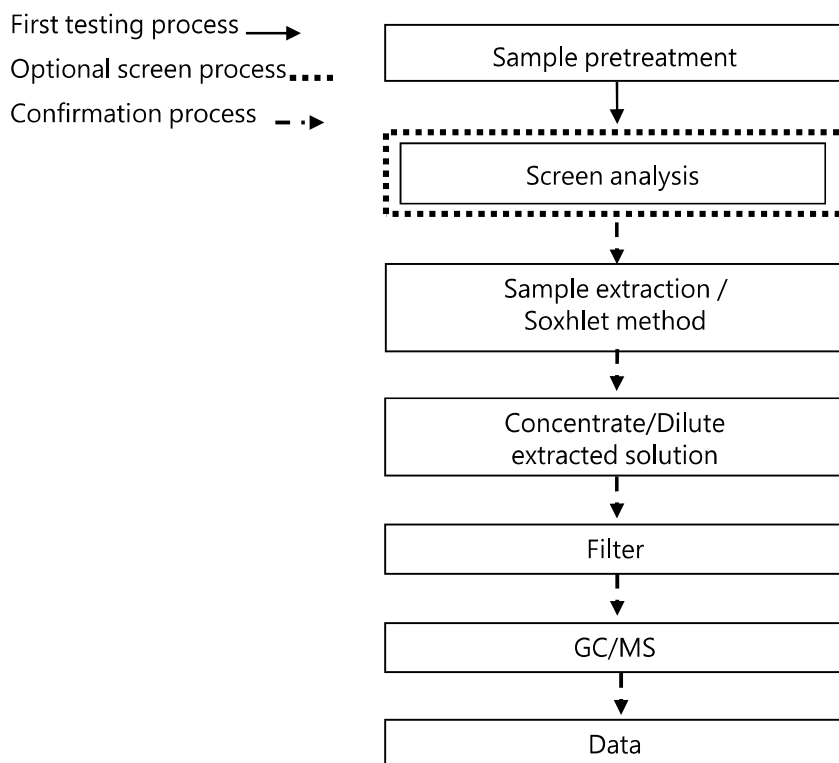

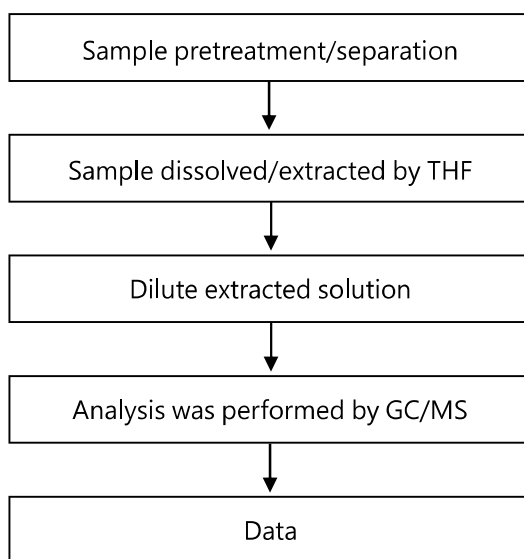

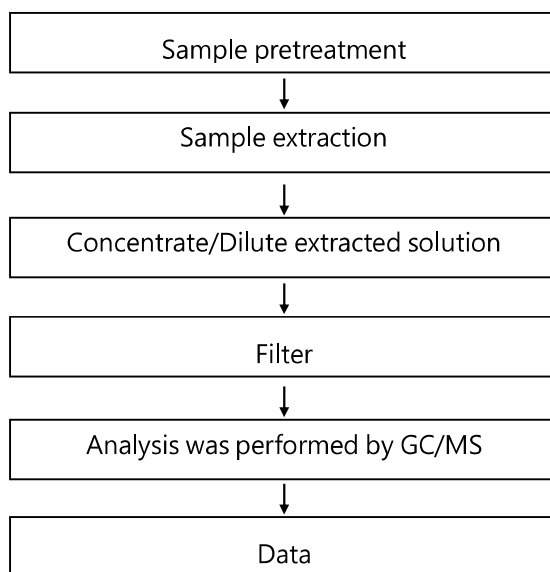

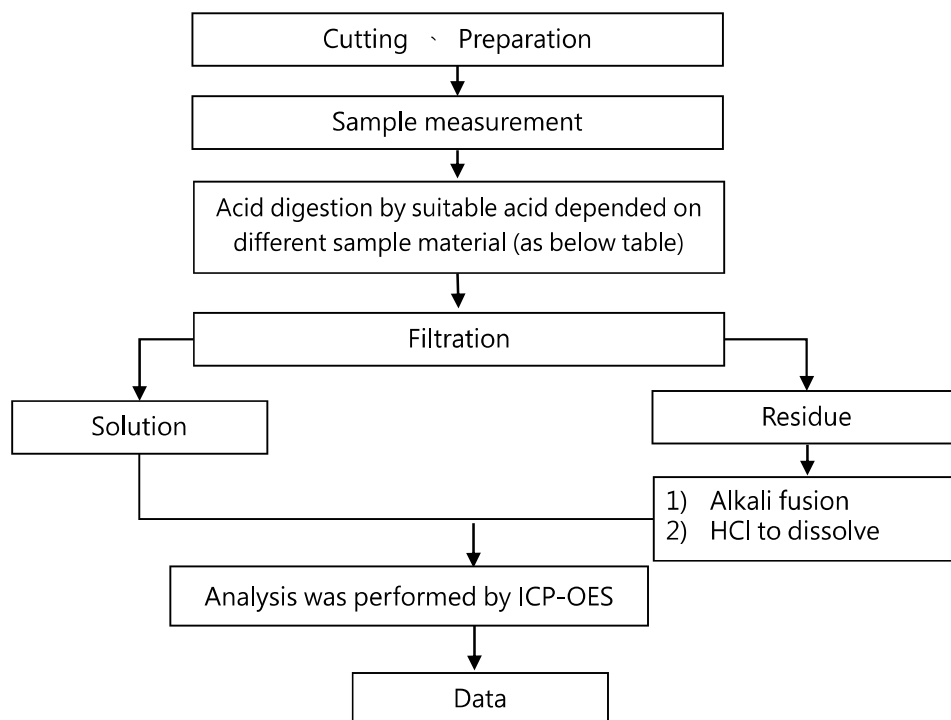
Analytical flow chart - HBCDD

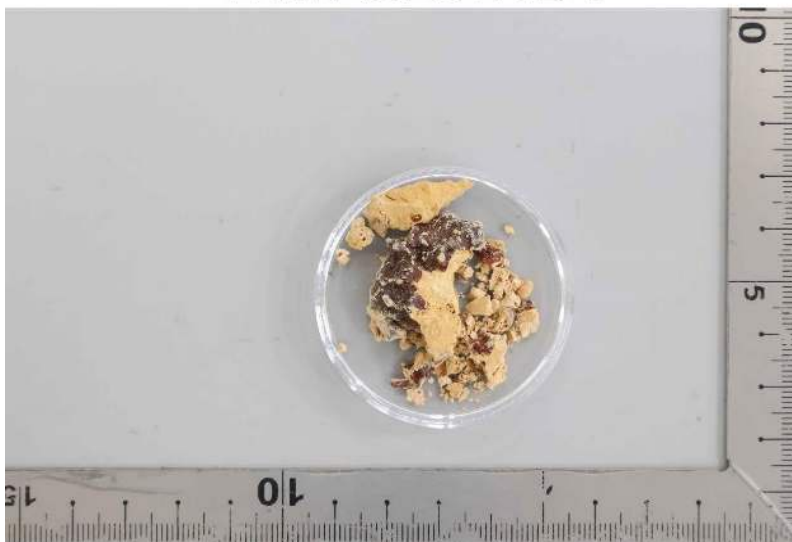
